3) Audio and Video Releasing Charges

- The charges include one-time royalty fees only.
- They do not cover promotion costs (both online and offline).

4) Royalty Revenue

- All royalty revenue generated from YouTube and other music network partners is the exclusive property of *Studio Beats Records* and *Web Crawl Technologies*.
- This revenue will not be shared with the artist.

5) Termination of Agreement

Upon termination or expiration of this Agreement, the Licensee (artist/user) must:

- Cease reproducing, advertising, marketing, and distributing the work as soon as commercially feasible.
- The Licensee has the right to fulfill existing orders and sell off existing copies of the work in stock.
- Studio Beats Records reserves the right to verify the validity of existing orders and copies upon reasonable notice to the Licensee.

6) Grant of Music License

- Studio Beats Records (Alias Web Crawl Technologies) retains title and ownership of the licensed property.
- The artist/user is granted a non-exclusive license to use the music under this agreement, subject to the following geographical restrictions:
 - › Music will be licensed and distributed on digital platforms under the exclusive ownership of Studio Beats Records.
 - › All digital revenue generated will be claimed solely by the company.
